

MOUNTING & WIRING


Allow at least three minutes for the unit to settle. The LED will not function until the unit is ready. Do not point the unit at sources of heat, such as radiators, space heaters, etc. Adjust beams laterally by sliding the Lens Support horizontally within its retainers. Loosen the Height Lock Screw and set the board's height scale to the mounted height of the unit. Retighten the screw. To extinguish the LED after walk-testing, cut the jumper (see "Circuit Board Detail", below).

Sensitivity Setting (SEN Jumper)

The unit is shipped with no jumper in this position. This is the normal sensitivity mode and is recommended for most installations. To have faster catch performance or for a range greater than 50 feet, install the supplied jumper on the SEN header.

Vertical Aiming (refer to lens coverage pattern)

The height scale that is on the board is intended to make vertical aiming guick and easy. If the board is set to the same number as the height the unit is mounted at, the unit will be aimed for maximum coverage. However, if the unit is used for less then the maximum range, move the board up (towards 12 ft.) and walk-test the unit. Note: If the wall upon which the unit is mounted is not vertical, move the board up or down and walk-test the unit. If using the Long Range Lens or Barrier Lens, set the board to 12 feet on the height scale as a starting point as aiming accuracy for long range lenses can greatly affect performance.
