**TERMS OF USE:** All Ethernet cabling runs must use CAT5 (or above). It is the professional installer's responsibility to follow local country regulations, including operation within legal frequency channels, output power, indoor cabling requirements, and Dynamic Frequency Selection (DFS) requirements.

## Installation Requirements

- For indoor applications, use Category 5 (or above) UTP cabling approved for indoor use.
- For outdoor applications, shielded Category 5 (or above) cabling should be used for all wired Ethernet connections and should be grounded through the AC ground of the power supply.

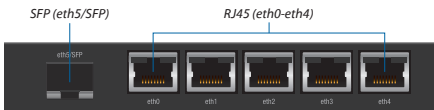

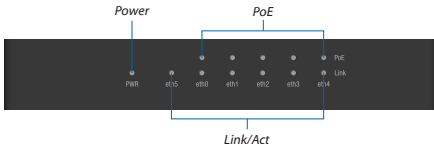

Reset	<p>There are two methods to reset the EdgeRouter X SFP to factory defaults:</p> <p><b>Runtime Reset (Recommended)</b></p> <p>The EdgeRouter X SFP should be running after bootup is complete. Press and hold the <b>Reset</b> button for about 10 seconds until the <i>eth4 Link</i> LED starts flashing and then becomes solidly lit. After a few seconds, the LED will turn off, and the EdgeRouter X SFP will automatically reboot.</p> <p><b>Power-on Reset</b></p> <ol style="list-style-type: none"><li>1. Disconnect the <i>Power Adapter</i> from the EdgeRouter X SFP.</li><li>2. Press and hold the <b>Reset</b> button while connecting the <i>Power Adapter</i> to the EdgeRouter X SFP. Keep holding the button until the <i>eth4 Link</i> LED starts flashing and then stops flashing after a few seconds.</li></ol>

Detail	Description
Ground	The EdgeRouter X SFP is grounded through the <i>Power Adapter</i> ; however, you can add optional ESD grounding for enhanced ESD protection. The ground wire and screw with washer are not included (recommended screw size: M3-0.5 x 4 mm).
Power	Connect the <i>Power Adapter</i> .

## Hardware Installation

Place the EdgeRouter X SFP on a flat, horizontal surface or mount it on a wall (mounting screws not included).

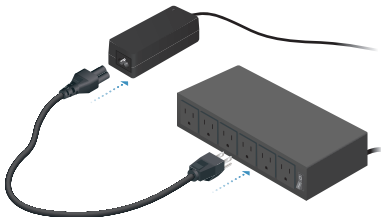

## Connecting Power

1. Connect the *Power Adapter* to the *Power* port.



2. Connect the *Power Cord* to the *Power Adapter*. Connect the other end of the *Power Cord* to a power outlet.

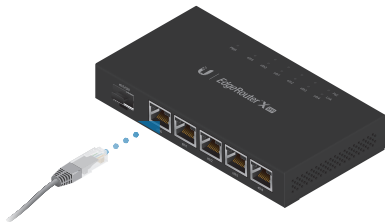


## Connecting Ethernet

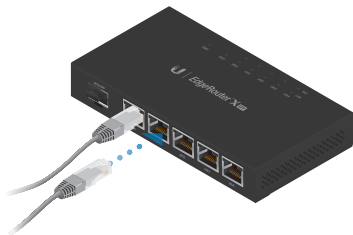
1. Connect an Ethernet cable from your computer or host system to the port labeled *eth0* on the EdgeRouter X SFP.



**Note:** PoE is disabled by default.



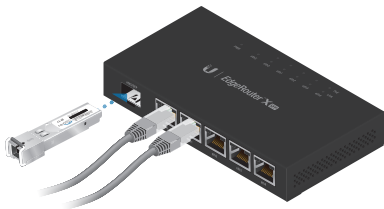
2. Connect Ethernet cables from the Ethernet ports of your devices to the rest of the ports in this range: *eth1-eth4*.



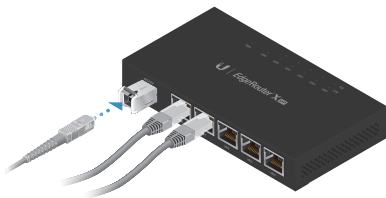
## Using the SFP Port (Optional)

To use the *eth5/SFP* port:

1. Remove the protective plug covering the *eth5/SFP* port.
2. Plug a fiber SFP module into the *eth5/SFP* port.



3. Connect a fiber optic cable to the fiber SFP module. Then connect the other end of the cable to another fiber device.



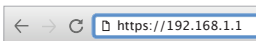

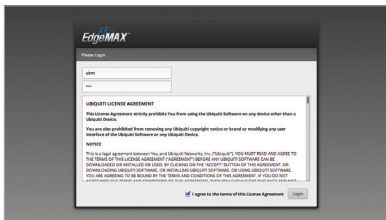
## Accessing the Configuration Interface

 **Note:** Ensure that your host system is connected to the *eth0* port of the EdgeRouter X SFP.

1. Configure the Ethernet adapter on your host system with a static IP address on the 192.168.1.x subnet.
2. Launch your web browser. Type **https://192.168.1.1** in the address field. Press **enter** (PC) or **return** (Mac).



3. The login screen will appear. Enter **ubnt** in the *Username* and *Password* fields. Read the Ubiquiti License Agreement, and check the box next to *I agree to the terms of this License Agreement* to accept it. Click **Login**.



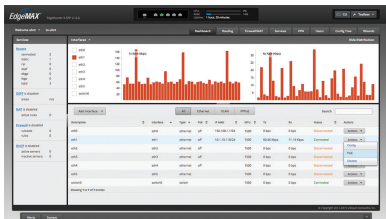

You can also manage your device using the Ubiquiti® Network Management System. UNMS™ lets you configure, monitor, upgrade, and back up your devices using a single application.

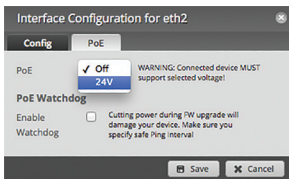
## Configuring PoE Settings

**! WARNING:** Before activating 24V passive PoE, ensure that the connected device supports PoE and the supplied voltage.

1. On the *Dashboard* screen, go to **Actions** > **PoE** for the interface you want to configure.



2. Select **24V** from the *PoE* drop-down menu.



3. Click **Save**.
